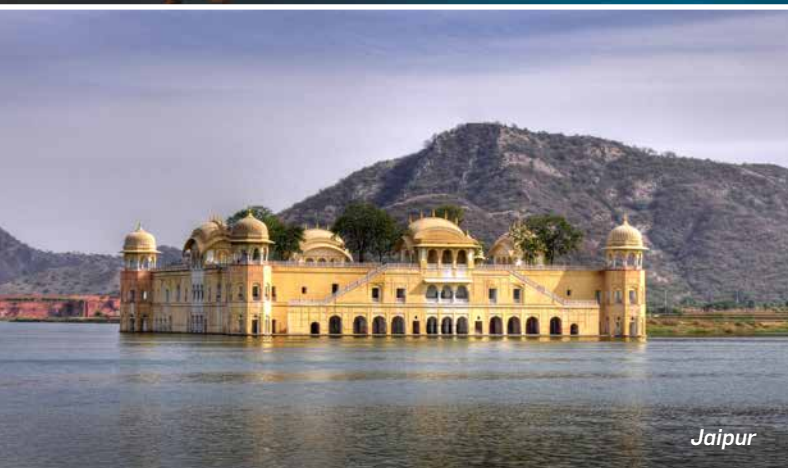

Terms & Conditions for Car Transfer Top-up:

- Suitable chauffeur driven car with comfortable seating limited up to 2 guests per car; 2 children below 8 years of age can share the same car with accompanying parents. Seating capacity to not exceed 05 guests including the chauffeur and guide (if any). You can carry maximum 2 pieces of luggage.
- Use of car is charged at a special price of INR 7500 per car per day plus Goods & Services Tax of 18% will be applicable.
- The car can be used for one of the following three services in one day:
 - a. Return airport transfers; or
 - b. Unlimited kilometer usage within the defined city limits for local sightseeing; or

Terms for Inter-city transfers:

- Inter-city transfers cannot be combined with Airport Transfers or Local Sightseeing package.
- Use of car beyond 250 kilometers in a day is chargeable at INR 50 per kilometer plus Goods & Services Tax of 18% will be applicable.
- Includes all currently applicable road toll taxes, parking charges and fuel costs.
- Overnight transfers and usage are not permitted.
